Background: The International Republican Institute (IRI) is a nonprofit, nonpartisan, organization dedicated to advancing freedom and democracy worldwide. Since 1983, IRI has worked to develop democratic institutions and ideals, carrying out a variety of international programs to promote freedom, self-government and the rule of law worldwide. IRI provides technical assistance in the areas of political party strengthening, developing civic institutions and open elections, promoting democratic governance and advancing the rule of law.

IRI is seeking applications from CSO partners in Nepal to implement advocacy campaigns based on entry points for addressing domestic political dimensions of kleptocracy and incentivize political actors to commit to anti-kleptocracy reforms. Subaward recipients may be selected from organizations that participated in IRI's recent strategic advocacy development workshop in Nepal. In consultation with IRI, selected CSOs will conduct targeted outreach and advocacy, engage with political actors to increase their understanding of processes that create openings for the transitionally enabled, systemic type of corruption that characterizes kleptocracy, propose targeted reform measures that address these gaps, and demonstrate the political benefits of doing so. IRI will provide the subaward recipient a report with learnings from IRI's workshop including landscape analysis and stakeholder mapping sessions to guide the target and scope of the campaign's proposed activities. IRI will also provide reports and materials from its work on global best practices when using advocacy to encourage transparency.

When identifying entry points for advocacy, CSOs should consider existing commitments that their governments have made within the context of international transparency and accountability frameworks. Illustrative frameworks may include the Open Government Partnership (OGP), the United Nations Convention against Corruption (UNCAC), Summit for Democracy commitments and other regional initiatives.

Statement of Work:

IRI will issue subawards to a selected CSO from Nepal to implement an advocacy campaign based on entry points for reform. Successful advocacy agendas will be centered around an issue that creates vulnerability to political dimensions of kleptocracy, such as insufficient policies regarding beneficial ownership of companies, asset disclosure for elected officials, political party financing regulations, and legal gaps that enable the functioning of in-country white collar kleptocratic facilitators. The selected CSO will advocate for related reform measures to address gaps in existing regulations.

While IRI encourages CSO applicants to customize their suggested subaward advocacy agenda based on the local political context in Nepal and their expertise to create an innovative campaign, the campaign's scope of work should include the following components:

- Design an advocacy agenda and strategy:
 - $_{\circ}$ CSOs will finalize the list of entry points for reform and design an advocacy agenda targeting political actors within and outside the government.
- Conduct an outreach campaign:
 - Engage actors across the political spectrum, improve their understanding of the existing policy and how it creates vulnerabilities to kleptocratic practices, and propose targeted reform measures.
 - May include public convenings and events and/or closed-door discussions.
- Identify political integrity champions:
 - o Identify a select group of political and reform-oriented actors, within and outside the government, who have demonstrated commitment to transparency, accountability, and openness to reform.
 - $\circ\quad$ Collaborate with political integrity champions to generate public commitment to reform.
- Develop integrity pledges with political integrity champions:
 - $\circ\quad$ Integrity pledges are non-binding social contracts through which participants announce their commitment to act against corruption.
 - Convene political integrity champions and collaborate with them to create political integrity pledges.

The elements above should be the core of the subaward proposal; however, applicants are encouraged to propose creative responses and activities.

Please address the questions below in the proposal concept:

- **Background**: What qualifications or past experience would help your organization to convene activists and leading organizations under the
- **Program Objectives**: What do you want to achieve through your work, and how will the work align with IRI's governance strengthening initiatives?

- **Staff Action Plan:** Please describe your role as a leader of the proposed initiative and how you plan on engaging and collaborating with partners.
- **Monitoring and Evaluation:** Please describe how you plan to measure the impact and effect of your program. Please use templates for pre-and post-surveys if possible.

Technical Applications:

All applications must include a comprehensive explanation of the methods to be used for implementation. Applications must not exceed 10 pages.

- 1. The first page of the application must show the following:
 - a. The name, address, UEI Number (when required) and telephone numbers of the Applicant (and electronic address if available);
 - b. A statement specifying the extent of agreement with all terms, conditions, and provisions included in the solicitation and agreement to furnish any or all items for which prices are offered;
 - c. A statement concerning whether or not the applicant has received a Negotiated Indirect Rate Cost Agreement from the US Government, currently or in the past. If yes, please attach NICRA.
 - d. Names, titles, and telephone and facsimile numbers, and electronic addresses of persons authorized to negotiate on the Applicant's behalf with IRI in connection with this RFA; and
 - e. Name, title, and signature of person authorized to sign the proposal. Applications signed by an agent shall be accompanied by evidence of that agent's authority, unless that evidence has been previously furnished to the issuing office.
 - f. The application must state the organization's indirect costs recovery methodology, which must be **ONLY** one of the following:
 - i. 10% percent de minimis rate; OR
 - ii. Current NICRA approved by the US Government (must attach copy); OR
 - iii. Direct charging of indirect costs.
- 2. Applicants shall provide a list of at least five previously executed awards of a similar nature for the last three years along with the contact details for each funder. IRI may contact the funder as a reference check.
- 3. Applicants shall provide a list of at least five program beneficiaries for previously executed grants of a similar nature for the last three years along with the contact details for each. IRI may contact the individuals as a reference check.
- 4. Applicants shall provide third-party evaluations of past activities if available.

- 5. All applications must include background on the organization's prior experience as it relates to the requested scope of work.
- 6. Resumes of all individuals who will be responsible for the programmatic and financial management of the award must be attached. Resumes must include level of proficiency in English
- 7. Application shall provide 3 References
- 8. Describe current and past projects and funding sources and any potential impact current activities might have on this award.
- 9. Describe accounting practices and organizational infrastructure, as well as technology and intellectual property owned by the organization, which will be used to complete the scope of work.
- 10. Applicants shall provide audited financial statements and management letters for the last three years.
- 11. Applicants shall provide a copy of legal registration documents (for organizations) or one form of legal ID (individuals). An English translation should be attached if necessary.
- 12. Applicants shall provide a statement detailing revenue from the last three years.
- 13. If selected for award, applicant may be required to provide detailed allocation if it selects direct charging of indirect costs and has multiple sources of funding.
- 14. The total length of the Program Description must not exceed five pages.
- 15. <u>All applications must include a comprehensive explanation of the methods to be used for implementation as a part of the Program Description</u>
- 16. Milestone Schedule
- 17. Cost Category Budget in IRI's template
- 18. Clear and verifiable milestones table
- 19. Copy of passport or other national identification for key staff
- 20. Using the attached checklist <u>below</u>, the applicant should indicate what information will be submitted for IRI's review.

Cost Applications:

The budget should be submitted in two forms: (1) a detailed, cost category budget and (2) a milestone budget.

1: Cost Category budget: A detailed budget in **US Dollars** including the specific line item costs outlined here must be submitted to estimate project costs. <u>Each application should also have a **detailed explanation** of why the budgeted amounts are necessary for completing the scope of work. The total amount budgeted for this project must not exceed **\$25,000.00 USD**.</u>

All one-time and recurring costs must be fully described in the budget. Rates should be quoted, inclusive of all but showing separately, costs of inspection, services, transportation, taxes, import duties if any and other levies.

- **Personnel** In general, employees receiving benefits from the applicant organization are considered staff. Consultants hired to assist with the program, who do not receive benefits, should be included under contractual. Identify staffing requirements by each position title and brief description of duties. For clarity, please list the annual salary of each position, percentage of time and number of months devoted to the project. (e.g., Administrative Director: \$30,000/year x 25% x 8.5 months; calculation: \$30,000/12 = \$2,500 x 25% x 8.5 months = \$5,312.5).

Evaluation and Award Process:

1. Applications will be evaluated by IRI for compliance with administrative requirements, previous experience of similar projects by the Applicant, technical capacity, the qualifications of the personnel for the project, and prices. IRI may contact the Applicant's previous clients and may obtain any information related to other projects that the Applicant has executed. IRI may contact any applicant for clarification or additional information, but Applicants are advised that IRI reserves the right to make decisions based solely on the information provided with the applications. IRI may but is not obligated to conduct additional negotiations prior to issuance of a contract and may at its sole discretion elect to issue contracts to one or more applicants.

- 2. Mathematical errors will be corrected in the following manner: If a discrepancy exists between the total price proposed and the total price resulting from multiplying the unit price by the corresponding amounts, then the unit price will prevail and the total price will be corrected. If there were a discrepancy between the numbers written out in words and the amounts in numbers, then the amount expressed in words will prevail. If the Applicant does not accept the correction, the offer will be rejected.
- 3. IRI may determine that an application is unacceptable if the prices proposed are materially unbalanced between line items or sub-line items. Unbalanced pricing exists when, despite an acceptable total evaluated price, the price of one or more contract line items is significantly overstated or understated as indicated by the application of cost or price analysis techniques. An application may be rejected if IRI determines that the lack of balance poses an unacceptable risk.
- 4. IRI will conduct a Technical/Price Weighted evaluation and source selection based on evaluation factors listed below. Technical evaluation factors have a total of 100 points; price evaluation has a total of 20 points. These factors will serve as the standard against which all technical information will be evaluated and identify the determination factors that Applicants should address. IRI intends to evaluate applications in accordance with the Statement of Work of this RFA and make an award to the Applicant achieving the highest combined score proposal (technical and cost), demonstrating both technical compliance and price reasonableness.
- 5. If a cost realism analysis is performed, cost realism may be considered in evaluating performance or price.

Evaluation of Applications:

- 1. The applications will be evaluated by a technical evaluation committee using the criteria shown below. When evaluating the competing applications, IRI will consider the written technical/capability information provided by the applicants, and any other information obtained by IRI through its own research.
- 2. The criteria listed below are presented by major category, so that Applicants will know which areas require emphasis in the preparation of their applications.
- 3. IRI will evaluate applications in accordance with the technical criteria and weightage shown in the table below. A total 100 points are assigned according to the following criteria:
